The HOA is in the middle of our annual mandatory dues collection. By paying your dues by 28 February 2025, you will avoid any late/penalty fees, and we want to ensure that you take advantage of this. Please see the table below and instructions for electronic payment:

Your HOA Board of Directors continues to execute our plan to incentivize all homeowners to pay their annual dues on time. This plan provides discounts for early payments, while retaining the official assessment with penalties for late payers as set forth in Article IV, Section 8 of the Declaration of Covenants.

<u>New Delinquent Dues Process</u>: As voted upon at our annual meeting on 17 November 2024. A proposal was presented and passed unanimously to address ongoing challenges of delinquent dues. Starting in 2025, homeowners/representative failing to pay their dues and fees/penalties by 15 March will be notified via a certified letter, warning them that failure to pay by 31 March will result in the case being handed to a collection agency. The charges for this service could exceed \$450.00 plus dues, fees/penalties and will be borne by the delinquent homeowner/ representative.
